- That the trustees shall always maintain proper accounts the Trust which shall be kept at the office on the Trust.
- Subject to the provisions of income tax Act 1961 as amended from time to time. The trust will keep the Trust fund of such portion thereof as they may in their absolute discretion think fit and proper without being answerable or accountable to the beneficiaries or any other party for any loss invested in such share stock securities and debentures of acquisition or mortgage by way of fresh charge on any immovable property in India, of free hold tenure and may deposit the amounts with any schedule bank company or private firm any individual on such terms and conditions as they think fit in the matter of investment of Trust funds the provisions of section 20 of the India Trust Act shall apply in the extent of Trustees purchasing any immovable property of advancing moneys or mortgage they shall be entitled to accept such title of evidence of titles as they shall think fit in their absolute and on controlled discretion. Power and function of the Bear settler cum Chairman

The settler cum president shall preside at all meeting of the trust, when he is present and shall exercise such other power as are conferred upon him by these rules.
